2. Status of Past-Due Dues Rebates (Updated May 21, 2012)

The Missouri Chapter paid all past due rebates, totaling \$2,760 on April 12, 2012.

3. 2011 Dues Rebates (Updated May 21, 2012)

a. Missouri Chapter

According to the former treasurer, the Chapter voted to begin quarterly rebates in April 2012 for each previous quarter. The new president has advised the section to provide the chapter with quarterly invoices. An invoice in the amount of \$233.75 was sent on February 14, 2012. The Section has not received payment thus far.

4. Status of 2012 Sponsorships (Updated May 21, 2012)

In FY2011, the Section attained sponsorships from eighteen organizations, collecting a total of \$6,350. The FY2012 budget calls for \$5,000 in revenue from sponsorships.

The Section has attained FY2012 sponsorship commitments from twenty-two organizations, totaling \$4,950. Thus far, 19 of the 22 committed sponsors have submitted payment, totaling \$4,250 received. A summary of the status of each committed sponsor is shown below.
